

RESOLUTION NO. 601

A RESOLUTION OF THE CITY OF WHITE SULPHUR SPRINGS, MONTANA, ESTABLISHING FEES FOR WATER AND SEWER INSTALLATIONS.

WHEREAS, the City has established a set of fees within Title 4 of the Municipal Code pertaining to its water and sewer systems; and

WHEREAS, the City has considered alterations to the substance of Title 4 and desires to remove the fees from the ordinance and adopt them by resolution so any changes to the fees in the future will not necessitate changes to the ordinance; and

WHEREAS, the City Council desires to reconsider those fees and make alterations to the fees.

NOW, THEREFORE BE IT ORDAINED AND RESOLVED BY THE CITY OF WHITE SULPHUR SPRINGS, MONTANA as follows:

The City of White Sulphur Springs hereby establishes the following fees for title 4 regarding water and sewer within the City of White Sulphur Springs:






